# **Item 1 - Fire Department Presentation**

Mr. Paul Hutt, Rural Sector Chief, District 9, gave a presentation on the actions taken by the firefighters during the Chiasson's fire in August 2009. In summary, the fire alarm was received at 5:19 am and the first fire truck arrived on site six to seven minutes latter. The fire had spread through the open web floor joists that contain special glue that also acted as the fire accelerant.

Mr. Hutt also talked about smoke and carbon monoxide alarms, the voluntary firefighters and the various type of firefighting equipment available in Greely.

The residents asked various questions about fire extinguishers and other ways to increase the fire protection in their house.

#### **Item 2 – Community Update**

- 1 Skating A pump was purchased to help with the pool maintenance and is available to anyone wishing to create a skating rink on the lakes/ponds. Contact for the pump is John Dawson. The rink on Twin Lake was a real success and many residents of all ages have enjoyed the ice time. Thank you to John Dawson and Jacques Brun who helped maintain the rink. It was emphasized that SLOA takes no responsibility for ice conditions or user safety.
- 2 Year in Review. An overview of the activities that were held in 2009 was presented that included the Spring/Fall Cleaning, garage sale, the Fundraising BBQ for the Chiassons.
- 3 Coyotes. Residents were reminded to remain vigilant at all times and that there was a community discussion regarding the problem to be held Thursday, 18 February at the

Community Center.

- 4 <u>SLOA Website and Community Board</u>. It was stated that the Board would be updating the SLOA website and all are incouraged to review it to keep uptodate with upcoming evets. Doug also fielded questions regarding road conditions in the local area and the exit from Tranquil Gate onto Mitch Owen.

#### **Item 7 – SLOA Annual Dues**

It was moved by Kerrin Mobbs and seconded by Heather Counsell – that an increase to the SLOA 2012 Annual Dues be increased to \$350 if deem necessary. Carried.

Note: It was also requested that the Board complete an audit of SLOA capital buildings to determine the size of reserve fund that is required to support maintenance of common areas. Should there be a mega project that would require more money than there is in the SLOA Reserve, a special contribution would be required. Any request to use reserve funds must be presented to the residence for approval.

#### Item 8 – Other

1 <u>Building the community together</u>. John Hiddema reminded everyone of their individual responsibilities within the SLOA Community. The SLOA Committee is not there as a law enforcement organisation but to encourage everyone to respect the covenants they agreed to when they bought their house.
