### Water quality and the effects of fertilizers

Let's face it. Water quality in our lakes and ponds is important to our entire community...not just the people who live on the lakes.

Elevated levels of algae have become a real concern in our waters over the last few years. Basically, algae survive, grow and multiply by feeding off of the nutrients (nitrogen, potassium and phosphorus) present in traditional fertilizers, that are running off our lawns and now highly present in our lakes.

Last summer we implemented a trial treatment of Twin Lake (the small lake) to address the increase in algae, using **NutraFX Algae**, a safe and natural product. The treatment consisted of an initial shock, followed by a full lake treatment, as well as treatments at identified "hot spots".

NutraFX Algae introduces a naturally occurring bacterium which outcompetes the algae for nutrients. The algae, now lacking a ready food source, cannot multiply and the introduced organism quickly dies off once the food sources become limited. The result is an increase in the water clarity, reduced sludge formation and improved overall health for the aquatic environment. Residents who reside around Twin Lake noticed a visible drop in the amount of algae and improved water clarity last summer following the trial treatments.

At the AGM this February, Mr. Roland Poirier from NutraFX was invited to make a presentation to inform residents about the problems and possible solutions. They are entering into Twin Lake in significant volumes at two "hot spots": the large culvert coming from Twin Lakes/Tranquil Gate and the culvert at the beach area at the North-East corner of the lake. These entry points feed runoff from the entire community into this lake.

As a solution, Mr. Poirier recommended continued treatment **but** he emphasized that without *eliminating* the use of fertilizers on our lawns this will be a **never ending battle**. The only permanent solution lies in total eradication of the use of traditional fertilizers.

Remember the NutraFX Algae is not a permanent solution, but merely a stop gap on an ever growing threat to our environment that we are causing.

### **Design Review and Covenants**

Fellow Sunset Lakes residents - welcome to spring! - the season of cool nights, warm days, rain, flowers and...landscaping and outdoor improvement.

Being a resident of Sunset Lakes confers many benefits and privileges. However, with those benefits come certain responsibilities, as dictated, primarily, by the *DEED RESTRICTIONS FOR SUNSET LAKES DEVELOPMENT CORPORATION COVENANTS AND RESTRICTIONS* which can be found online at <u>http://www.sunsetlakes.ca/sunsetlakes/sunset\_index.htm</u>.

In that document, sections 3(v) and 10 broadly define the type of structure and landscaping that is considered "in keeping" with the Sunset Lakes philosophy. Walking around the community observing the homes and landscaping gives you some insight into the "Sunset Lakes philosophy" but you probably have more questions - that is where the SLOA board's Design Review Committee comes in. Made up of volunteer Sunset Lakes' owners, i.e. your neighbours, this Committee has the responsibility of performing a design review of your proposed project and to ensure that both the letter and spirit of the Sunset Lakes Covenant is maintained.

The Design Review Process is intended to help promote individual creativity, encourage owners to thoroughly plan their projects, and allow for the coordination of architectural diversity to create a blend of home styles which enhances the overall aesthetic of the neighbourhood. It is NOT the intent of the Design Review Committee to make judgments as to what is or is not beautiful or to unduly hamper or restrict the owner.

The Design Review Process is supplemental to the requirements outlined in the Covenants and Restrictions for Sunset lakes, which provide the legal basis for reviewing and accepting design proposals. Further information on the Deed Restrictions can be found online at <u>www.sunsetlakes.ca/sunsetlakes/sunset\_index.htm</u>. As for the Design

Process itself, it consists of the following steps:

- **Step 1** Review existing homes, landscaping and exterior structures to get an idea of previously accepted designs;
- **Step 2** Submit a concept sketch and discuss your ideas with a member of the Design Review Committee (presently John Dawson or Daniel Weslake) to ensure that you are heading in the right direction;

- **Step 3** Submit a formal Design Review Application (available online at <u>www.sunsetlakes.ca/sunsetlakes/design review application.doc</u> Where appropriate; i.e. for large projects; prepare plans with sufficient detail to ensure that a proper assessment can be made (with new home construction requiring the most information including, but not limited to building plans, elevations (of all four sides) and a site plan (depicting house, driveway, lamps, set back distances, square footage, etc.), including amendment suggestions; and
- Step 4 Receive written Design Review Approval.

For more information, contact, the SLOA by email at <u>sloa@rogers.com</u> and include any questions, concerns or details that you may have regarding your project. Since the Design Review Process is not meant to be onerous, a response is issued, typically, within a day or two - depending on the nature and extent of the information required to ensure a proper response. The entire SLOA board is here to assist our fellow residents not to serve as a hindrance.

So, get your designs on paper, contact a Design Review Committee member and get your project rolling....
